LEGAL NOTICE VILLAGE OF NORTH COLLINS, NY TAX COLLECTOR'S NOTICE OF RECEIPT OF TAX ROLL AND WARRANT

PLEASE TAKE NOTICE that I, Janet L. Hutchinson, Tax Collector for the Village of North Collins, have received the Tax Roll and Warrant for the year 2018-19 and have been commanded to receive and collect property taxes for the Village of North Collins.

OFFICE: Office hours will be maintained for the purpose of receiving taxes on said roll at the Village Hall, 10543 Main Street, North Collins, New York 14111, between June 1, 2018 and July 2, 2018.

REGULAR OFFICE HOURS: Monday through Friday 8:00 am to 4:00 pm.
Evening hours on Wednesday from 5:00pm to 9:00pm.

PARTIAL PAYMENTS are not accepted.

DROP BOX: You may leave your non-cash payment in our drop box located to the left of the door at the Village Hall.

PLEASE TAKE FURTHER NOTICE, taxes paid in person or POSTMARKED on or before July 2, 2018 will not receive penalties. After July 2, 2018 and through July 31, 2018, a 7.5% penalty will be added. From August 1, 2018 through August 31, 2018, an additional 1.5% interest will be added for a total of 9.0%. From September 1, 2018 through October 1, 2018, the penalty and interest will increase to 10.5% and from October 2, 2018 through October 31, 2018, the penalty and interest will increase to 12.0%.

PLEASE TAKE FURTHER NOTICE, on November 1, 2018 the above-described Tax Warrant will be returned to the Erie County Commissioner of Finance. All unpaid property taxes must be paid to the Erie County Commissioner of Finance, 95 Franklin Street, Buffalo, New York 14202, (716) 858-8333.
